Proposed Club Bylaws Amendment

The Club's board of directors recommends that the Club adopt the following proposed change to the Club By-laws. The change is to Article IV (Election of Directors and Officers), Section I, paragraph 5 which refers to the nomination of the Club President Nominee.

Currently the Section reads: "The nominating committee shall consist of the five most recent

past presidents of the club who are still members of the club and are willing to serve. The committee shall elect from its members a chairman."

The proposed amendment would revise Section 1 to read as follows: "During the month of September the Club President shall convene a committee to nominate the next Club President Nominee. This nominating committee shall consist of the Club President, the Club President Elect and three Club Past Presidents, preferably the three most recent past presidents, who are still members of the club and are willing and able to serve. At the date and time set by the Club President this committee will meet and as their first item of business elect one of their members other than the Club President as its chairman. The committee's business shall be to nominate a member of the club as the Club President Nominee (president to follow the current Club President Elect) and three members of the club to serve on the next Rotary year's board of directors, replacing those members who have finished their two year term."
