#### **Rotary Ambassadorial Scholarships**

Rotary District 5160 is seeking qualified applicants within our community for Rotary Foundation Ambassadorial Scholarships for the Rotary year 2009 - 2010. The scholarships are designed to further international understanding and goodwill. They provide for study abroad in more than 150 countries where Rotary Clubs are located. # **Proposed Club Bylaws Amendment**

The Club's board of directors recommends that the Club adopt the following proposed change to the Club By-laws. The change is to Article IV (Election of Directors and Officers), Section I, paragraph 5 which refers to the nomination of the Club President Nominee.
